General criteria include: (1) prior or current service in the Asian Pacific American community, with emphasis in the Filipino-American community; (2) leadership roles and experience; (3) academic excellence; and (4) financial need\*.

## Instructions

- (1) All applicants must provide a PDF copy of their current resume. <u>Law students</u> must provide a PDF copy of their most recent law school transcripts (unofficial transcripts are acceptable). <u>Incoming law students</u> must provide a PDF copy of their most recent college transcripts (unofficial transcripts are acceptable) *and* a PDF copy of their law school acceptance letter for the 2021-2022 school year.
- (2) Include typed responses to the application questions.
- (3) Remember to sign the application. An e-signature is acceptable.
