

## KEYNOTE SPEAKER



The Hon. Eric C. Taylor

Presiding Judge

Los Angeles Superior Court

On January 1, 2021, Judge Eric C. Taylor became the 71st Presiding Judge of the Los Angeles Superior Court, having been elected on September 9, 2020 to serve for 2021 and 2022. Judge Taylor was previously elected Assistant Presiding Judge, serving for 2019 and 2020.

Judge Taylor was appointed to the Inglewood Municipal Court in 1998, serving as Presiding Judge prior to trial court unification. He was subsequently appointed Superior Court Site Managing Judge for the Inglewood Courthouse. In 2001, he was appointed Assistant District Supervising Judge of the Southwest District. From 2002-3, he served as Supervising Judge of the Southwest District. In his 23 years on the bench, Judge Taylor has worked on numerous LA Court committees – including Legislative, Family, Security, Civil Grand Jury, and Bench-Bar Outreach. In 2011, he was elected to the Superior Court Executive Committee, serving from 2011-13; and is currently serving as the Chair of the Court's Executive Committee.

In 2003, Judge Taylor was elected President of the California Judges Association ("CJA") after serving on its board for 2 years. While president, Chief Justice Ronald George appointed him as an advisory member to the California Judicial Council. In 2015, he became the first judge to be elected for a second time as President of CJA, and to again serve on the Judicial Council under Chief Justice Tani Cantil-Sakauye.

During his first presidency, Judge Taylor helped to revitalize CJA, overhauling its publications, increasing its presence in Sacramento, and traveling to over 25 counties to expand and solidify membership, and to give judges a strong voice throughout the State. In his second term, he again led efforts to promote membership and a more proactive association concerning issues related to the quality of justice in California and the dignity of the judiciary. Judge Taylor also chaired CJA's Public Information and Access Committee, and served on the editorial board of its main publication, "The Bench."

Chief Justice George appointed Judge Taylor to the Judicial Council's Access and Fairness Committee to serve from 2000-3. Judge Taylor also served on the Steering Committee for the California Judicial College, where he also served as a discussion group leader.

Prior to the bench, Judge Taylor worked as a Deputy County Counsel for Los Angeles County, practicing in the Civil Litigation, Sheriff's Civil Defense and Public Works Divisions. He also practiced as a litigation associate at Sonnenschein, Nath and Rosenthal, and the former law offices of Pettit and Martin. In 1986, he served as an extern to California Supreme Court Justice, Allen E. Broussard.

Judge Taylor holds a J.D. from the University of Virginia School of Law, and a B.A. from Dartmouth College. At Dartmouth, Judge Taylor was a Gould Foundation Scholar and sang for four years with the Dartmouth Aires. At Virginia, he chaired the Migrant Farmworkers Legal Project and co-chaired the Law Public Services Program. Judge Taylor recently finished a 12-year term as a trustee of the Cate Preparatory School where he served as Vice President, and has taught as an adjunct professor at Loyola Marymount University since 2013.

## DISTINGUISHED JURIST



The Hon. Teresa P. Magno Los Angeles Superior Court

Judge Teresa P. Magno was born and raised in the Philippines. She and her family immigrated to the United States in 1987 when she was sixteen years old. She graduated from UCLA in 1994 with a major in History and Asian American Studies. She attended UCLA School of Law and graduated in 1997.

After practicing with a civil law firm for a year and working as a research attorney for then Los Angeles Superior Court Judges Judith Ashmann-Gerst and David Horowitz, Judge Magno joined the Los Angeles County District Attorney's Office in 1999, where she earned a reputation as a hardworking prosecutor dedicated to making communities safer, and seeking justice for victims of senseless gang violence. In the 15 years she was a deputy district attorney, she completed 94 jury trials.

From 2006 to 2013, she served in the elite Hardcore Gang Division where she prosecuted exclusively gang homicide cases. In the seven years she served as a gang prosecutor, she tried 41 gang murder cases and five gang attempted murder cases. In spite of the inherent challenges in prosecuting gang cases in which witnesses were required to risk their lives by appearing in court, she obtained guilty verdicts in all but two of these 46 jury trials. In 2013, she was assigned to the Organized Crime Division/Hate Crimes unit, where she prosecuted hate crimes and human trafficking cases.

In June 2014, she was elected to the L.A. Superior Court and became, not only the first Filipino American to be elected to the bench, but also the first Filipino American to successfully run in a Los Angeles county wide race. In endorsing her candidacy, the Metropolitan News indicated, "... A canon of ethics requires that a judge be patient, dignified and courteous. For Magno, compliance would not be difficult... those qualities are part of her basic nature."

Judge Magno has a criminal law assignment and is currently assigned to the Compton Courthouse. As a superior court judge, she has served on several California Judges Association committees, including the Diversity & Inclusivity, Outreach, and the JET-PAC, and Los Angeles Superior Court committees, including Teen Court, Trial Jurors, and the committee of judges that selects ICDA attorneys who handle capital cases.

Judge Magno has been active in the California Asian Pacific American Bar Association (CAPAJA), serving as its president in 2019. Judge Magno is also one of the founding members of CAPAJA-PAC, a political action committee committed to assisting Asian and Pacific Islander judges who have served with distinction to defeat frivolous and sometimes xenophobic election challenges.

In 2019, she was appointed by Chief Justice Tani Cantil-Sakauye to the Court Interpreters Advisory Panel, a committee that assists the Judicial Council in performing its duties through promoting access to spoken-language interpreters and interpreters for deaf and hearing-impaired persons.

## DISTINGUISHED ADVOCATE



Toni Jaramilla

In an Asian American Studies class at UCLA, Toni Jaramilla was assigned to interview an Asian immigrant. She chose her father. Her dad immigrated from the Philippines and served in the US Navy. Despite his veteran status, he faced blatant bigotry due to his national origin. He found work in Northern California as an agricultural worker. He and other Manongs experienced oppressive working conditions and low wages, which led to the Delano grape strikes and boycotts.

After settling in Los Angeles, he and Toni Jaramilla's mother worked hard to provide her with life-changing opportunities. As a result of their sacrifices, She is the first in her family to obtain a law degree. Toni Jaramilla's career as a workers' rights attorney is built on fighting discrimination and advocating for racial equality. Her determination and success are inspired, in no small part, from experiences passed down by her father.

Since 1994. Toni Jaramilla has represented hundreds of workers against discriminatory employers, achieving multiple millions of dollars in state and federal jury verdicts, settlements, and arbitration awards. Her cases are often followed by news media, such as her representation of five young women in the "take-down" of American Apparel and the ousting of its founder and CEO for sexual assault.

Her activism extends to litigating civil rights cases involving police brutality and shooting deaths, many of which have also been featured in the press. During the civil unrest following George Floyd's murder and global #BLM protests, she was invited to meet with LA Chief of Police Michel Moore and LA County Sheriff Alex Villanueva, to discuss the abuse of peaceful protestors. Along with other civil rights leaders, Toni Jaramilla advocated for greater transparency and accountability by law enforcement who abused their power.

As an advocate for women's rights and pay equity, during the #MeToo movement, she helped introduce and advance legislation directed toward strengthening protections against sexual harassment and gender discrimination. Shoulder to shoulder with her client—who had been sexually assaulted at work but missed her deadline to file her lawsuit—they testified at the State Capitol in support of Assembly Bill 9, a bill that extended the statute of limitations from one to three years for pursuing claims under the California Fair Employment and Housing Act. This game-changing legislation benefits all California employees by giving them more time to file claims of discrimination and harassment. Governor Newsom signed the bill into law, effective January 1, 2020.

Toni Jaramilla is passionate about promoting diversity and inclusion, both in the practice of law and in leadership roles. In 1998, she proudly served as President of the Philippine American Bar Association, providing outreach and support to the Pilipino community. In 2004, she was selected Chair of the Labor & Employment Section of the California State Bar (the third largest), the first Pilipina to hold that position. In her first Board meeting, Toni Jaramilla proposed that they establish a diversity grant program and allocate \$75,000 to fund bar organizations, particularly multi-cultural bar organizations presenting educational programs on employment law. Almost two decades later, that grant program still exists today.

From 2011-2013, Toni Jaramilla served as Chair of the California Employment Lawyers Association (CELA), the largest statewide organization of workers' rights advocates in employment law. Under her leadership, she helped start diversity initiatives, including (1) creation of a standing Diversity Outreach Committee, (2) initiation of an annual diversity lunch with an inspirational keynote speaker; and (3) creation of scholarships and fellowships for diverse law students committed to practicing plaintiff-side employment law. She also co-founded the Foundation for Advocacy Inclusion and Resources (FAIR), the nonprofit sister foundation to CELA, which raises funds and awards fellowships to new lawyers with diverse backgrounds who seek to practice plaintiff-side employment law.

Currently, Toni Jaramilla is Vice Chair of the Diversity Equity and Inclusion Committee of the California Lawyers Association. She helped draft and propose a speaker diversity policy, adopted by CLA, which ensures that racial and gender diversity is consistently reflected in speaker selection. They are now expanding that policy to include board and section appointments.

## TRAILBLAZER AWARD

Mia Frances Yamamoto (formerly Michael Francis Yamamoto) was born in Poston Relocation Camp, Arizona, in 1943, She graduated from Cal State University Los Angeles with a B.S. in Government in 1966. From 1966 to 1968, Mia served in the U.S. Army, 4th Infantry Division, USARV, and was awarded the National Defense Service Medal, Army Commendation Medal, Vietnam Campaign Medal, and Vietnam Service Medal.

In 1971, she received her J.D. from the University of California, Los Angeles School of Law, where she co-founded Asian Pacific Islander Law Student Association. Mia worked for the Legal Aid Foundation of Los Angeles from 1971 to 1974. From 1974 to 1984, she worked as a Deputy L.A. County Public Defender and California State Public Defender and has worked in private practice since 1984.

Mia previously served as President of California Attorneys for Criminal Justice, a statewide organization of 2,500 private and public defenders; co-founder and Chair of the Multi-Cultural Bar Alliance, a coalition of minority, women's and LGBT bar associations of Los Angeles; President of the Japanese American Bar Association; and President of the Asian Pacific American Women Lawyers Alliance. She also served on the California Judicial Council State Task Forces on Jury Improvement and Access to Justice.

Mia was the co-founder of the Asian Pacific American Bar Association of Southern California and founding board member of International Bridges to Justice, a human rights group providing Due Process education and advocating against investigative torture for the judicial systems of China, Southeast Asia, the Middle East and Africa, having previously served on the boards of the L.A. County Bar Association, Korean American Bar Association, and ACLU of Southern California. She is a Lifetime Member of Women Lawyers Association of Los Angeles, member of the National Lawyers Guild, and Lifetime Member of PABA.

Mia has contributed to a variety of classroom lectures, demonstrations, and panel discussions including the panel on "Race and Criminal Justice", George Washington University, for President Clinton's Initiative on Race in 1999; "Cultural Defenses, Pro and Con" and "Community Law Practice" for the ABA in 1999, Atlanta; "Miles to Go" ABA in 2000, New York City; "Cultural Defenses" and "Lawyers in the Media" for the 1999 NAPABA Convention Los Angeles; "Elimination of Bias" Consumer Attorneys of California, SF in 2008 and Los Angeles County Bar Association in 2008, 2009, 2011, and 2013. She is a frequent media commentator on issues relating to criminal law and a variety of related issues for: (print) LA Times, LA Daily Journal; (radio) KPFK, KPCC; (television) KCAL, Fox, NBC, KCET, MSNBC, CNN, Court TV and other cable and foreign media.

Her Past Honors include awards from the Criminal Courts Bar Association, Women Lawyers Association of Los Angeles, and National Lawyers Guild. She was named "Criminal Defense Attorney of the Year" by the LA County Bar Association in 2002; named one of the "100 Most Influential Lawyers in California" by the California Daily Journal in 2002; "Criminal Defense Attorney of the Year" by the Century City Bar Association in 2006; and voted "Southern California Super Lawyer" by her peers, LA Magazine, each year from 2005 to 2019. She was awarded an ABA's "Spirit of Excellence" award in 2007 and NAPABA "Trailblazers" Award in 2008.

Mia is a recipient of the Rainbow Key Award from the City of West Hollywood, 2011; "Sisters Standing Up For Love" API-Equality 2012, The Harvey Milk Legacy Award, LA Pride and Christopher Street West 2012; and the Liberty Award LAMBDA Legal 2012. She served on the ABA's Commission on Sexual Orientation and Gender Identity. She was one of three recipients of the inaugural Stonewall Award from the ABA on February 9, 2013. She received the Good Neighbor Award from Equality California on September 20, 2014. She was a featured speaker in Trafalgar Square for "Pride in London", June 27, 2015, as well as for the "Interlaw Diversity Panel", June 29, 2015, London, England.

## COMMUNITY CHAMPION



Jessica Caloza

Jessica Caloza is a Commissioner on the Board of Public Works, the governing and oversight body of more than 5,500 employees responsible for delivering critical services and infrastructure projects in the City of Los Angeles. She was appointed by Mayor Eric Garcetti in February and confirmed by the City Council in March 2019. She is the first Filipina American to serve on the Board and is the lead Commissioner for the Bureau of Engineering.

Previously, Jessica served as Mayor Garcetti's Director of Scheduling since 2017, overseeing the Mayor's entire scheduling operation — including strategic planning, day-to-day logistics, and coordination with various Departments and agencies. She also served as Deputy Director of Scheduling, and came to the Mayor's Executive Office from the Office of Immigrant Affairs, where she helped lead the City's immigration policy, grant programs, and civic engagement initiatives focused on expanding access to resources for immigrant communities.

Prior to joining the Mayor's Office, Jessica served in the Obama Administration in the U.S. Department of Education — where she worked on higher education policy, Congressional and legislative affairs, student data and privacy, immigration policy, and gender equity issues. She has also been a campaign aide to several members of Congress, including former Rep. Xavier Becerra; former Rep. Mike Honda; and Rep. Albio Sires. In 2012, she was a community organizer for President Obama's reelection campaign and helped lead various field offices in Virginia.

Jessica is also passionate about giving back to the community and volunteers with various Asian American and Filipino American organizations. In 2014, she was selected as one of ten delegates for the Filipino Youth Leadership Program (FYLPro), an international leadership program led by the Ambassador of the Philippines. Most recently, she served on the boards of KAYA: Filipino Americans for Progress, FYLPro Executive Committee, and the Leadership Council of the Center for Asian Americans United for Self Empowerment (CAUSE).

Jessica is a graduate of the University of California, San Diego and is a proud first-generation immigrant.

## THE AIMEE CONTRERAS-CAMUA PABA FOUNDATION SCHOLARSHIP IN MEMORY OF RICHARD LOU CONTRERAS



Richard Lou Contreras (March 6, 1967 – June 26, 1982)

This scholarship is awarded to a promising student who is interested in pursuing a legal degree, and has demonstrated a commitment to academic excellence and the advancement of the Filipino-American community. Aimee Contreras-Camua, a PABA Foundation Board Member and 2019 PABA Trailblazer Awardee, created this scholarship in honor of her brother, Richard Lou Contreras, who passed away from aplastic anemia at the age of 15 years old while he was a sophomore at Loyola High School.

Richard has been an inspiration to all who were blessed to have known and loved him, especially to his parents, Ricardo and Rebecca Contreras who adored him, and to his younger sister who looked up to him as her first friend and mentor. Richard will forever be remembered for his huge smile, dry humor, and happy personality, all of which never waned even while he bravely battled cancer. His terminal illness and sudden death took a financial and emotional toll on their family.

If not for the financial generosity and mentorship of family and strangers, Aimee would not have had been able to graduate from UCLA as both an undergraduate in 1995 and a law student in 1998. Her hope is that each recipient of this scholarship will similarly pay it forward, and in due time, serve as a mentor and provide financial assistance to future promising Filipino-American students.


## Blaine Valencia - The Jose Y. Lauchengco, Jr. Memorial PABA Foundation Scholarship

Through the financial support of our generous donors, PABA proudly announced the establishment of four Named Scholarships:

- The Jose Y. Lauchengco, Jr. Memorial PABA Scholarship 2020 Awardees: Joshua Alegado (Loyola Law School), Kimberly Morosi (Southwestern Law School), and Michael Tayag (Yale Law School);
- The Joe Sayas Law Foundation PABA Scholarship 2020 Awardee: Eldrin Masangkay (UCI School of Law);
- The Richard Lou Contreras Memorial PABA Scholarship 2020 Awardee: Dan Lorenz Cruz (Loyola Law School); and
- The Ben Hofileña PABA Scholarship 2020 Awardee: Anastasia Olano (Loyola Law School).

To help address law students' and recent law graduates' financial hardships during the pandemic, PABA and the PABA Foundation established the **COVID-19 Emergency Scholarship Fund**. Through the generosity of our members and the community, PABA and the PABA Foundation were able to provide emergency funds to six law students and recent graduates: Darryn Albert (Loyola Law School), David Gonzalez (Loyola Law School), Karina Laigo (California Western School of Law), Gabrielle Mercurio (Notre Dame Law School), Kayla Wales (Chapman University School of Law), and Monica Zafra (McGeorge School of Law).

For our community, PABA presented a free six-part virtual webinar series to address pressing pandemic-related legal issues, including tenants' rights, debt-relief measures, estate planning, employment law, domestic violence and abuse, and immigration law. We helped promote participation in the 2020 Census. We encouraged civic engagement by participating in a voter protection program spearheaded by PABA Past-President Philip Nulud and Commissioner Jessica Caloza, the 2021 PABA Community Champion Awardee. We supported our board members' work to Stop Asian Hate. PABA also issued statements taking a stand with the Black community against systemic racism, injustice, and police brutality, encouraged our community to be anti-racist, and celebrated the Supreme Court's decision in *Bostock v. Clayton County, Georgia*. PABA participated in an IALA event honoring Chief Justice Cantil-Sakauye with a Lifetime Achievement Award from over 20 local bar organizations. PABA also supported the appointment of Assemblymember Rob Bonta as California's next Attorney General.




